Pivot Bio's Ultimate Ranch Truck Sweepstakes Official Rules

- 1. **Eligibility**: The Pivot Bio's Ultimate Ranch Truck Sweepstakes (the "Promotion") is open only to eligible participants who meet all the following criteria:
